

2012-2013 Hudson ISD Report on Violent and Criminal/Non-Criminal Incidents

Texas statute requires every district to publish a report on violent or criminal incidents at their schools. This annual report must include: (a) a statement of the number, rate, and type of violent or criminal incidents that occurred on each district campus, to the extent permitted under the Family Educational Rights and Privacy Act of 1974 and (b) information concerning school violence prevention and intervention.
